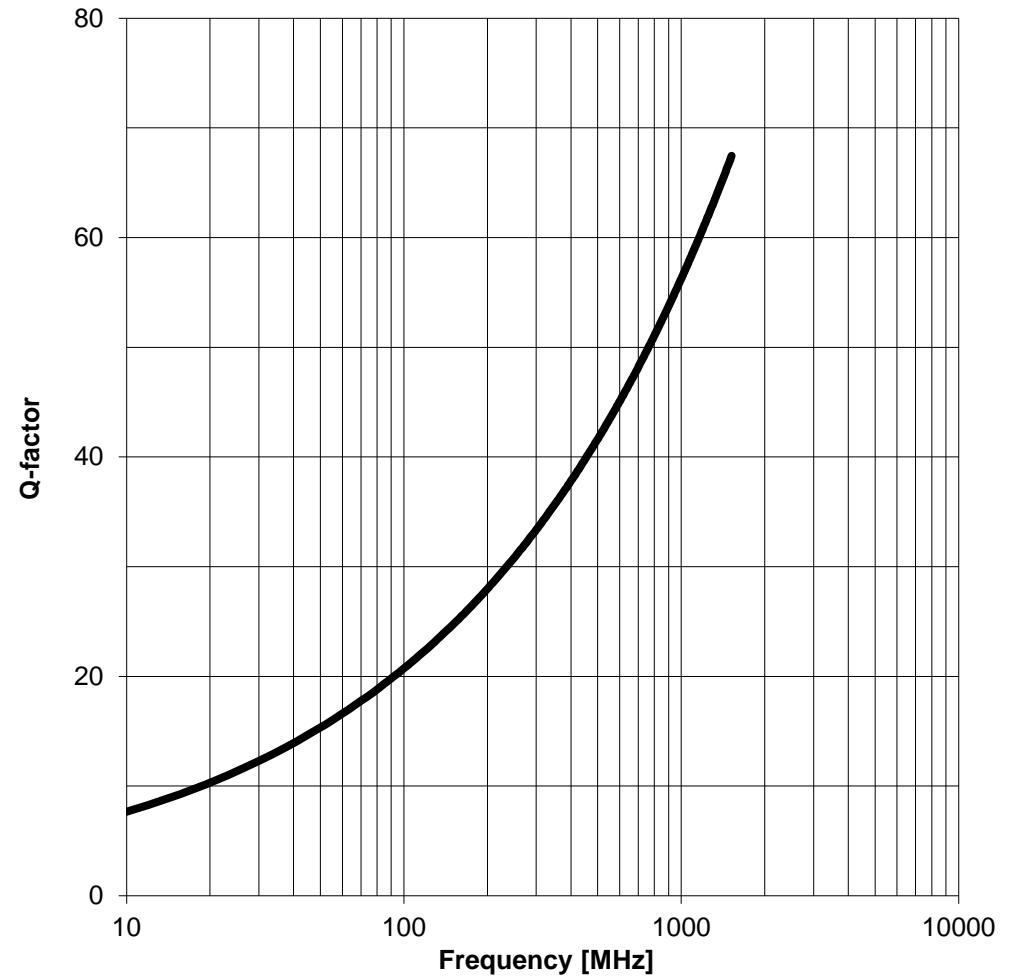

Q-Factor vs. Frequency:



Cleaning agents that are used to clean the customer application might damage or change the characteristics of the component, body, pins or termination.



Direct mechanical impact to the product shall be prevented as the core material could flake or in the worst case it could break.

- Please notice that the recommended thickness of the soldering paste is 120 µm.


